——I hereby authorize the INKED BY FLAWLESS EGO's Artist: to perform the following cosmetic tattooing procedure.

-----I understand the nature of the procedure and understand that the procedure will result in a change in my appearance and that no representations have been made to me as to the ability to later change or remove the result. I accept responsibility for determining the shape, color, and position of the pigment to be applied and understand that my skin color, texture, scar tissue, skin tone and skin condition may modify the final color of the healed pigment. I understand that the known complications of cosmetic tattooing include: redness, swelling, puffiness, bruising,

----- COMPLAINTS: I understand that the known complications of cosmetic tattooing include: redness, swelling, puffiness, bruising, dry patches, tenderness, bleeding, infection, color loss,

delayed wound healing. In addition to these potential risks, there may be other unpredictable risks. I understand that it is not reasonable to determine whether I might have an allergic reaction to any of the pigments, dyes, topical preparations, or processes used in the procedure and accept the risk that a reaction is possible. There is no refund on the procedure once completed. Unsatisfactory complaints on my behalf are at my own risk and I have read the terms of service below. By proceeding beyond this page, I agree to and am bound to the Terms of Service and cannot take any legal actions against my artist or clinic.

----- IMPORTANT INFORMATION: All permanent makeup requires a minimum of two appointments. I understand and expect that each procedure is a process and requiring multiple applications of pigment to achieve desirable results. And that 100% success cannot be guaranteed. I understand that therefore, I need to return for a touchup procedure that is not included in the initial price. I understand it for the touchup. There is an additional fee. I understand that it is my responsibility to inquire about how much my touchup fee will be. Your touch up session will be needed within 6-10 weeks of your first session. To ensure that your touch up is scheduled within 6-10 weeks of your first appointment we will schedule your appointment at the end of your initial appointment; otherwise, your missing your followup appointment can fall outside the allotted time frame and be subject to additional fees due to the additional time/work will needed to achieve the desired results.

----- Additionally, if you do not come for your 6-10 week touch up it will be considered a new procedure when scheduling your next appointment due to the amount of time/work that will be needed. Initial sessions vary in price. and Brow Touch up (6-10 week) and Annual Touch up (anything after 10 weeks) is \$_____ NO EXCEPTIONS

----- PLEASE NOTE: We provide the same service for every client, but the healed results can vary with every client due to pigment retention. This is dependent on your immune system, skin type, lifestyle, any medications taken, and the before and aftercare instructions. Therefore, Healed results are beyond our control.

----- CHANGING YOUR / TECHNIQUE / COLOR / SHAPE: If you decide to do another technique, change a shape, color, or thickness on your follow up or annual touch up appointment, extra fees will be applied (\$150). _____ an additional follow touch up will be required 6-10 weeks after your appointment to achieve the desired results, since this will be the same as doing a new procedure a \$ _____ is required at this 2nd appointment.

----- PREVIOUS PERMANENT MAKEUP FROM ANOTHER ARTIST / COVERUP CORRECTION:

If you had your permanent makeup done by another artist and are interested in a cover up/correction/rework, you must first get approval by sending us photos of the existing work. If you fail to do so, we will have the right to refuse service on the day of your appointment. As a result, your deposit will be forfeited (NO EXCEPTIONS) Not all previous tattoos from other artists can be fixed or covered, it varies case by case. We do not guarantee good results with tattoo cover ups or neutralization due to the skin already being compromised by old tattooing/pigmentation/incorrect depth.

_____ Even with A neutralization treatment or laser treatment, There is no guarantee that the tattoo Ink will cover up old tattooed brows. Or will adhere to the skin. You will not hold the artist at Inked by my flawless, ego responsible.

----- STUDIO POLICY: No guests, no children, and no pets are allowed in the treatment area due to cross-contamination and interruption. Please be respectful and understand that the PMU artist must focus on the permanent tattoo procedure. Or Brow Service and We also want to ensure the safety of our staff & clients.
